In 1988, Brazilian entrepreneurs, representatives of Toledo Scale in Brazil, bought Toledo do Brasil. Since then, the company has become national, private, and independent.

Today, Toledo do Brasil has a factory in São Bernardo do Campo - SP, with a built area of 21,430 sqm (m²) on a plot of 62,643 sqm (m²), 20 branches, and hundreds of representatives throughout the country.

SAFETY RECOMMENDATIONS



Access to the premises is only allowed if the visitor is accompanied by the person responsible for the visit;

Do not enter areas signaled and/or isolated by zebra (black-and-yellow) tapes;



Drivers/motorcyclists – maximum speed allowed: 10 km/h;



EMERGENCY

When listening to the audible alarm, accompany the person responsible for the visit.

In case of building evacuation, follow the Emergency Brigadiers' guidelines and the procedures to leave the area.


